### 6.1 Personal precautions, protective equipment and emergency procedures

Personal Protection Ensure no sources of ignition. Avoid breathing vapour. Use approved personal protective equipment. Evacuate area immediately. Do not allow general use of area until it is safe to do so. Beware : vapour is heavier than air and will tend to accumulate at low spots.

#### 6.3 Methods and material for containment and cleaning up

Major Spillage Absorb into dry earth or sand. Transfer absorbent to salvage container for removal. Wash area down with copious amounts of water. Minor Spillage Absorb into dry earth or sand. Transfer absorbent to container for removal. Allow solvent to evaporate in remote area, then dispose of absorbent as solid chemical waste. Wash area down with copious amounts of water.
